BOM - Water and Land: Forecast Wind have indicated a North-Easterly blowing towards Sydney between 15-20 knots. This can be attributed to pushing the smoke from surrounding areas of northern NSW onwards. OEH PM _{2.5} exceedances were recorded across most sites within Sydney-East with over 65% of sites exceeding the 25 µg/m ³ goal .
