**\*Note:**

Driver means the person driving or in charge of any vehicle. Where the Notice is served on the person who was the registered operator, or person nominated as driver, of the vehicle at the time of the detailed trip(s), liability of the person upon whom this notice has been served may be removed if the Statutory Declaration (above) is returned within 30 days of the date of the Notice. This is conditional upon the information provided by the registered operator or person nominated as driver. The registered operator and the nominated driver cannot both be punished for failing to pay the toll if it is established that they are not the same person.
